## Reminder of the EPR and its obligations

The **Extended Producer Responsibility (EPR)** principle requires marketers to manage the waste prevention and end-of-life of the products they place on the market. Since January 1<sup>st</sup>, 2007, French law has implemented this measure for new Clothing, Household linen, and Footwear intended for the end consumer.

As such, all clothing, household linen and footwear **marketers** are required to contribute to an authority approved eco-organisation - Refashion - in order to comply with their legal obligation.

The **Unique Identification Number (UIN)** ensures that the marketer is duly registered with the eco-organisation and has fulfilled its financial contribution. It may be activated or deactivated each year depending on the marketer's status.

As a reminder, companies subject to the EPR that are not in compliance and do not have an active UIN are exposed to :

- An **administrative fine of €30,000**, in accordance with Article L541-9-5 of the Environmental Code,
- Legal **proceedings by the DGCCRF** for non-compliance with consumer information requirements.

## The eco-fee

Refashion is the eco-organisation for the Clothing, Household linen and Footwear sector. Our mission is to bring together and support all stakeholders from production to consumption and regeneration to reduce impacts and create value. Your eco-fee, as a marketer, fund the implementation of actions that help us meet the objectives set out in our specifications.

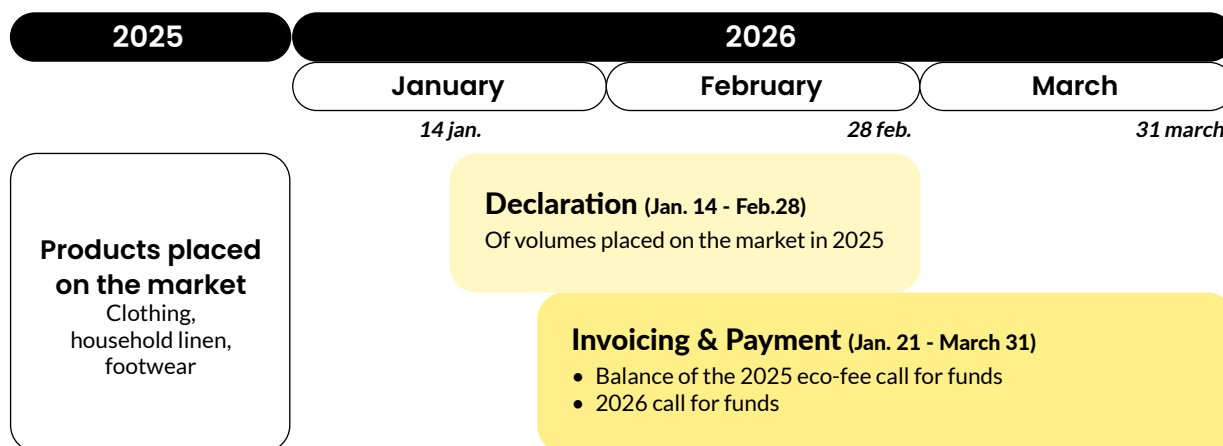


# Details of the declaration

The declaration of products placed on the market in 2025 will take place from **January 14 to February 28, 2026**

## → Eco-fee invoicing

Following the declaration of products placed on the market in 2025, **you will receive 2 invoices:**

- An invoice or credit note for the 2025 eco-fee call for funds balance (based on the 2025 scale),
- An invoice of the 2026 eco-fee call for funds (based on the 2026 scale).

The 2026 eco-fee call for funds is calculated as follows:

$$\left( \textcircled{1} \times \textcircled{2} \right) + \textcircled{3} + \textcircled{4}$$

## → Eco-modulation

To encourage the most responsible eco-design practices and discourage harmful ones to deal with the end of your products, Refashion offers a system of bonuses and penalties: **the eco-modulations**.

The following eco-modulations have been applied since January 1<sup>st</sup>, 2025:

- Bonus for durability,
- Bonus for certification with environmental labels,
- Bonus for the use of recycled raw materials,
- Penalty related to the recyclability of textiles and footwear products: metalloplastic fibers,
- Penalty related to the recyclability of textiles and footwear products: electrical and electronic components.

# 3 steps to fulfill your declaration and be in compliance



## 1 Login to extranet

- Go to the **Extranet** (before submitting your declaration)
- Update the company information and the designated contact for the declaration: «the declarant\*»

*\*Please note that this person will be responsible for the entire declaration process.*

## 2 Declaration of products placed on the market (from January 14 to February 28, 2026)

In the tab «Your Declarations», submit your declaration for products placed on the market in 2025

- or
- **Detailed** (accessible regardless of the volumes placed on the market) refer to Appendix I
  - **Simplified** (for volumes placed on the market < 5000 items/year) refer to Appendix II

*The declaration deadline is February 28, 2026 for quantities placed on the market in 2025.  
Beyond this deadline, late penalties will be applied.*

## 3 Payment of the eco-fee (from January 21 to March 31, 2026)

- Pay or receive the balance amount of the 2025 eco-fee call for funds
- Pay the 2026 eco-fee call for funds

Invoices are sent via email and can be downloaded from the «Your Invoices and Certificates» tab on the **Extranet**. No invoices are sent by mail.

You have the option to pay by credit card or bank transfer.

*The payment deadline is March 31, 2026. After this deadline, late penalties will be applied.*

The declaration is completed as quantities placed on the market per product category: Clothing, Household linen, Footwear.

**The per-item scale is increased.**

This high rate covers the non-declaration of products eligible for eco-modulations and the lack of traceability.
