



DETAILED DECLARATION BY FILE IMPORT GUIDE

Welcome to the step-by-step guide that will help you complete your Refashion member registration in order to regularize your status and obtain your UIN. This guide is dedicated to detailed declaration by file import of your items placed into the market.

BEFORE YOUR BEGIN:

- Make sure you have completed your Refashion member registration and signed your contract.
- Make sure you are the declarant for your company.
- As a reminder, the detailed declaration is accessible to all marketers, regardless of the number of items placed on the market in the previous year, and is compulsory for those benefiting from eco-modulations.



- 1 Go to the "Your declarations" tab.
For your information, "Completed Declarations" refer to those from previous years that you can freely review.
- 2 Click on "Declarations to be processed" and then click "Start".

Step 1: declare your products and quantities

AS A REMINDER

You are required to declare **the quantities placed on the market in the previous year for the current year.**

For the 2026 declaration, which opens in January 2026, you must declare the quantities placed on the market in 2025.

- 3 Select the product family(ies) related to your items sold by checking the appropriate box(es).
If in doubt, you can access a list of products subject to the textile sector by clicking on the (i) icons.

AS A REMINDER

You can access the official glossary of products liable to the textile sector:


- On the extranet, under the "Your Tools" > "Declaration" section;
- On our website refashion.fr/pro/en, in the "Marketer" section, under "Liable companies and products" by downloading the non-exhaustive list of products concerned to regulation;
- In our FAQ, under the article "What does the marketer declare?".

4 Enter the exact number of items you placed on the market in 2025.

5 Choose your declaration method. Here, select the detailed declaration with "file import." Then proceed to the next step.

6 Download the declaration help file to complete by clicking on the button.

Step 2: fill out the declaration help file on Excel

Go to your downloads and open the Excel file on your computer.

Please note, to ensure the file remains compliant once completed, you must not alter its layout in any way.

7 Enter the required information in the tab corresponding to the relevant territory or territories.

8 Input your company's legal name, which you can find on the extranet if needed.

9 Report the quantities placed on the market in column G of the table (the last column) for the corresponding product lines.

You can check the "Summary" tab on the Excel to have an overview of the quantities entered by product category and territory. The table updates automatically and requires no additional action from you.

Please ensure that you declare all the units sold in sets (e.g. a set of 5 baby's bodysuits = 5 bodysuits to declare, a set with pyjamas, socks and a nightcap = 1 pyjama + 1 pair of socks + 1 nightcap to declare).



10 Once you have completed your file, save it on your computer in XLSX format. **This is the only format that can be uploaded on the extranet.**

If you are unable to save the file in XLSX format or do not have Office 365, please contact our hotline via email at hotline@refashion.fr.


Contact the hotline only after the file is COMPLETED, as they are not authorized to fill out the declaration file on your behalf.

Step 3: verify data and finalize declaration

- 11** Return to the extranet and click on « upload the completed declaration help file » button. Then, « choose a file » > « import an Excel file ».

The data are automatically populated on the Extranet from the imported file. Review the data for accuracy.

You can then access the summary (by clicking the corresponding button) or save and come back later. You can go back to correct information by clicking "Previous."

- 12** Accessing the summary allows you to verify the entered quantities. Then, click on **"Validate the declaration" to complete the process.**

Once the finalization of your declaration is validated, you will not be able to go back or modify any data.

Your declaration is complete!

It is now been submitted to Refashion.
