SIMPLIFIED DECLARATION GUIDE

Welcome to the step-by-step guide that will help you complete your Refashion member registration in order to regularize your status and obtain your UIN. This guide is dedicated to the simplified declaration of your items placed into the market.

BEFORE YOUR BEGIN:

- Make sure you have completed your Refashion member registration and signed your contract.
- Make sure you are the declarant for your company.
- Reminder: **The simplified declaration** is only available to marketers that placed **fewer than 5,000 items placed on the market in the previous year** and do not benefit from eco-modulations. If you placed more than 5,000 items on the market and/or benefit from eco-modulations, please refer to the detailed declaration guides.

Go to the "Your declarations" tab.

For your information, "Completed Declarations" refer to those from previous years that you can freely review.

2

Click on "Declarations to be processed" and then click "Start".

Step 1: declare your products and quantities

AS A REMINDER

You are required to declare **the quantities placed on the market in the previous year for the current year**.

For the 2026 declaration, which opens in January 2026, you must declare the quantities placed on the market in 2025.

Select the product family(ies) related to your items sold by checking the appropriate box(es).

If in doubt, you can access a [list of products subject to the textile sector](#) by clicking on the (i) icons.

AS A REMINDER

You can access the official glossary of products liable to the textile sector:

- On the extranet, under the "Your Tools" > "Declaration" section;
- On our website refashion.fr/pro/en, in the "Marketer" section, under "Liable companies and products" by downloading the non-exhaustive list of products concerned to regulation;



AS A REMINDER:

- The simplified declaration is only possible **if you are not eligible for eco-modulations.**
- The simplified declaration allows you to complete your declaration in 2 steps, by product category. **However, an increased price per item is applied.**

- 5 Choose your declaration method. Here, select the detailed declaration with "file import." Then proceed to the next step.

6 Enter the corresponding quantities by product category.

7 Download the “Sworn statement” by clicking on the download link (🖱️). This document is mandatory. **The declaration will be rejected if the sworn statement is not valid.**

Two templates are available:

- One to be completed by the legal representative;
 - The other to be completed by the accountant;
- ➔ Complete one of the two templates based on your authorization, using the file downloaded to your computer.

8 Once completed, upload the document to the extranet by clicking on “Choose a File”.

9 Click “Next” – you can then review the accuracy of the data and view the uploaded document. *If needed, you can go back or save to complete the declaration later.*

10 Then click on “access to the summary” to review the entered quantities. After verifying, click on **“validate the declaration” to complete the process.** **Once validated, the data cannot be modified.**

Your declaration is complete!

It has now been submitted to Refashion.
